## PPK FUTSAL COMPETITION 2009

The competition shall be open to all members (MALE only) who will be required to enter their TEAM(s) comprising of eight (8) participants each.

ALL participants will be required to comply with the following rules and regulations:

- 1 A total of eight (8) participants will comprise one team and only five (5) players per team are permitted on the pitch at any one time. A maximum of two (2) teams from any one corporate member will be permitted to participate.
- 2 Each team must be given a team name and are advised to don their own team's attire/jersey which must be numbered from No. 1 to 8. Only futsal shoes are allowed inside the playing area. *Football boots are not considered as futsal shoes.*
- 3 All team members must be employees of the owner and/or management company of the shopping centre or office building but may be made up from different departments within the same company or be individual members of the same company.
- 4 The participation fee per team shall be RM300 per team which is non-refundable. This fee will only cover cost of rental for the premises during the duration of the competition but *EXCLUDES* all other incidentals eg. transport, food, drinks and other equipment etc.
- 5 Prizes will be awarded as follows in each of the categories:
  - Champion – will be awarded the Challenge Trophy
  - 1<sup>st</sup> Runner Up
  - 2<sup>nd</sup> Runner Up
- 6 Game Duration and Format : The duration shall be two (2) equal periods of seven (7) minutes each. The game format shall be advised at a later stage depending on the number of teams participating.
- 7 The Start of Play Procedure shall be by coin toss followed by kick-off, while the opposing team waits outside the centre circle. The ball is deemed in play once it has traveled the distance of its own circumference; the kicker shall not touch the ball before someone else touches it. Ensuring kick-offs must be taken after goals scored and at start of the second half.
- 8 Fouls and Misconduct: A direct free kick is awarded when a player intentionally commits any of the following 10 offences (a penalty kick is awarded when infringement takes place in the penalty area) :
  1. Kicking or attempting to kick an opponent
  2. Tripping an opponent
  3. Jumping at an opponent
  4. Charging an opponent in a violent or dangerous manner
  5. Charging an opponent from behind
  6. Holding an opponent
  7. Pushing an opponent
  8. Charging an opponent with shoulder (i.e. shoulder charge)
  9. Sliding at an opponent (i.e. sliding tackle)
  10. Handling the ball (except the goalkeeper)

9 Ball in and out of Play

- Ball out of play: when it has wholly crossed the goal line or touchline; when the game has been stopped by a referee;
- Lines: touchlines and goal lines are considered inside the playing area.

10 Method of scoring: When the whole of the ball has passed over the goal line, between the goal posts and under the crossbar (except by illegal means).

11 Free kick

- Types: direct free kicks and indirect free kicks
- Wall: at least 5m. away until the ball is in play
- Ball in play: after it has traveled the distance of its own circumference
- Time limit: kick must be taken within 4 seconds
- Restriction: kicker cannot touch the ball again until it has been touched by another player
- Goalkeeper picks up or touches with his hands a kick-in from a team-mate
- Goalkeeper controls the ball with any part of his body for more than 4 seconds
- Goalkeeper touches with any part of his body a backpass that has been played back to him before the ball has (i) crossed the halfway line or (ii) been touched by an opponent

12 Players shall be cautioned (i.e. shown yellow card) when:

- A substituting player enters the pitch from an incorrect position or before the player he is substituting has entirely left the pitch
- He persistently infringes the Laws of the Games
- He shows dissent with any decision of the referee
- He is guilty of ungentlemanly conduct
- These 4 yellow card offences are punishable by an indirect free kick taken from the point of infringement (or from the 6 m. line when the infringement takes place in the penalty area)

13 Players shall be cautioned (i.e. shown a red card) for:

- Serious foul play
- Violent conduct
- Foul or abusive language
- Second instance of cautionable offence (i.e. second yellow card)
- Intentionally impeding a clear goal opportunity (i.e. though a 'professional foul')
- Intentionally impeding a clear goal opportunity in the penalty area by handling the ball
- Direct free kicks (or penalty kicks) accompany the expulsion (from the 6 m. line when the infringement takes place in the penalty area)

14 Rules of Expulsion:

- The player sent off is out for the rest of the game and is not even permitted to sit on the reserves' bench
- The team of the player sent off can substitute for that player after 2 minutes of playing time or after the opposite team scores, whichever comes first
- The 2 minute punishment shall be checked by the time keeper (or by the assistant referee, if there is no timekeeper)
- The substitute cannot come on until the ball is out of play and he has a referee's consent

15 Kick-in:

- To be taken in place of the throw-in
- The ball is placed on the touch line before kicking
- The kicker's foot not kicking the ball must be outside or at least on the touchline; if it crosses the

touchline all of the way, into the pitch, the kick-in is given to the opposing team

- The kick-in must be taken within 4 seconds; if this is not done, the kick-in is given to the opposing team
- The kicker cannot play the ball a second time until it has been played by another player; infringement of this rule entails an indirect free kick to the opposing team from the point of the infringement
- Players on opposing teams must be at least 5 m. away from the point of kick-in
- Cannot score directly from a kick-in

16 Goal Clearance:

- To be taken in place of goal kick
- From inside the penalty area, the goalkeeper throws the ball into play
- The ball is not in play until it has passed outside of the penalty area

17 Corner kick:

- The ball placed on the corner (no corner kick arc). If the ball is misplaced, the corner kick is taken over.
- Must be taken within 4 seconds; failure to do so entails indirect free kick to the opposing team from the corner mark
- The kicker cannot play the ball a second time until it has been played by another player; infringement of this rule entails a direct free kick to the opposing team from the point of infringement
- Players on opposing teams must be at least 5 m. from the point of the corner
- Can score goal directly from a corner kick

18 All decisions eg. match fixtures etc. and results determined by the Organising Committee shall be final and no correspondence will be entertained.

19 All players (including related/invited spectators) participate in the competition solely at their own risk and the Organisers will not be held liable for any consequences whatsoever arising thereof.

PPK BOWLING COMPETITION 2009

The competition will be open to 2 categories, *which shall be run concurrently on the same day* :

- CATEGORY A: TEAM and,
- CATEGORY B: INDIVIDUALS.

All participants will be required to comply with the following rules and regulations:

CATEGORY A: TEAM

1. A maximum of three (3) teams from any one corporate member will be permitted to participate, with 3 persons per team of which at least one must be female.
2. Each team must be given a team name.
3. All team members must be employees of the owner and/or management company of the shopping centre or office building but may be made up from different departments within the same company or be individual members of the same company.
4. Team individuals who are playing in CATEGORY A: TEAM will also be in the running for the Special Award for Best Individual Team Player. Therefore, team individuals who register for CATEGORY A: TEAM will not be permitted to register for CATEGORY B: INDIVIDUAL.
5. The participation fee per team shall be RM100.00 which is non-refundable. This fee will only cover cost of rental for the premises and bowling balls only during the duration of the competition but *EXCLUDES* all other incidentals eg. transport, food, drinks, hiring of shoes and other equipment etc.
6. The competition will be played over 3 games on the said date.
